

## The Paget's Association Website Terms and Conditions

### BACKGROUND:

This agreement applies as between you, the User of this Website and the Paget's Association, the owner of this Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.

No part of this Website is intended to constitute a contractual offer capable of acceptance with the exception of any order for merchandise and our acceptance of that offer is deemed to occur upon our sending a confirmation email to you indicating that your order has been accepted.

### 1. Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

<b>"Account"</b>	means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Website;
<b>"Content"</b>	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Website;
<b>"Facilities"</b>	means collectively any online facilities, tools, services or information that the Paget's Association makes available through the Website either now or in the future;
<b>"Services"</b>	means the services available to you through this Website, such as membership of the Paget's Association and online shop.
<b>"Payment Information"</b>	means any details required for the purchase of Services from this Website. This includes, but is not limited to, credit / debit card numbers, bank account numbers and sort codes;
<b>"Premises"</b>	Means our place of business located at Jactin House, 24 Hood Street, Ancoats, Manchester, M4 6WX, United Kingdom.

<b>“System”</b>	means any online communications infrastructure that the Paget’s Association make available through the Website either now or in the future. This includes, but is not limited to, web-based email, message boards, live chat facilities and email links;
<b>“User” / “Users”</b>	means any third party that accesses the Website and is not employed by the Paget’s Association and acting in the course of their employment;
<b>“Website”</b>	means the website that you are currently using (www.paget.org.uk and any sub-domains of this site unless expressly excluded by their own terms and conditions; and
<b>“We/Us/Our”</b>	means the Paget’s Association. Registered charity registered no. 266071.

- 10.1 Either the Paget's Association or you may terminate your membership. If we terminate your membership you will be notified by email and an explanation for the termination will be provided. Notwithstanding the foregoing, we reserve the right to terminate without giving reasons.

## 11. **Services, Pricing and Availability**

All pricing information on the Website is correct at the time of going online. All pricing

is in sterling. We reserve the right to change prices and alter or remove any special offers from time to time and as necessary.

## **12. Orders and Provision of Services**
